Judge David Heckler, Bucks County Court of Common Pleas, wished for a phone call regarding a traffic violation he had witnessed this morning at approximately 0855hrs., at the intersection of E. Court St. and Church St. In speaking with Mr. Heckler, he reported that he was at the intersection, traveling eastbound on E. Court St. Mr. Heckler reported that he was stopped at the stop sign, and observed a red SUV traveling westbound on Church St. Mr. Heckler reported that he observed the vehicle approach the intersection, and that the operator made very little attempt to slow or stop before proceeding through the intersection, and in front of him.

Mr. Heckler followed the vehicle, a red Chevrolet Blazer, and was able to obtain tag information of PA vehicle stopped for the traffic light at Church St. and N. occurred on 06-29-05, at approximately 0855 hours, at the intersection of Church St. and Lacey Ave. Stated that he had been assaulted by an unknown white male at that intersection.

Refer to incident report #20050629M1189, whereas, Ofc. Hilton had investigated a complaint of a motor vehicle violation reported by David Heckler on 06-29-05, and at the conclusion of his investigation, issued a traffic citation via summons.

The following information is based on switten and verbal statements to me. Present during the interview was Lt. Cummings.

The incident occurred on Wednesday morning at approximately 8:45-8:55 AM, on 06-29-05. I was driving toward Main St., and pulled up to a four-way stop sign. My car came to a complete stop, and I looked in all directions. A white Supra came up on my left. I proceeded to go half-way through the intersection and heard the sound of a car horn. I looked to my left and noticed the driver of the white car sitting a little above his stop sign. I continued on, as I had done nothing wrong. Instead of going straight, the driver of the white car had swung behind me and proceeded to drive up right on my bumper. I was passing a church on my left, where small children often cross the street, so I made my way slowly down the hill. The driver of the white car stayed right on my bumper, hitting his horn several times. At this point, I had no idea who the maniac behind me was. At the intersection ahead of me the light was turning yellow, so I stopped my car because it seemed as if the irate driver behind me was going to follow me wherever I went.

I came to a stop, and I saw the fellow behind me, an overweight, middle age man, with white hair, step out of his car. At this point, I was scared for my life. I did not know if it was some psycho with road-rage who just wanted to get in to a fight, or who the guy thought he was. My windows were down. He stepped up to my car, all the while yelling at me. I was buckled in my seat at the time, so I turned to look at him. He came up to my window, and asked if I knew what I did. I told him to step away from my car. He got extremely angry and got right next to my window. He lifted his hand, at which time I thought something bad was going to do down. He made a half punch, half slap at my head. He connected with my upper forehead, knocking my hat over.

At this point, I was not going to sit in my car and get assaulted. I put my car in park and pushed him away from my car with my car door. I got out of my car to show him I wouldn't be bullied. He backed off slightly, and I said "Who do you think you are". He responded, "You will be hearing from the police". He turned around and walked back to his car. I got back in to my car and drove off when the light tuned green. At no point did he identify himself as a judge. It was not until when I called Ofc. Hilton that I learned that he was a judge.

- A. I was traveling west on Church St.
- Q. What occured at the intersection of E. Court St. and Church St.?
- A. I stopped at the stop sign, and there were no other vehicles when I I observed the white Toyota come up on my left on E. Court St. I started through the intersection and heard a car horn. I saw that the white Toyota was partially in to the intersection. I continued on Church St. and observed that the white Toyota had made a wide turn, and now was tail-gateing me as I was going down the hill. I then stopped for a yellow light at the bottom of the hill.
- Q. What happened at the traffic light at Church and Lacey?
- I opened my car door, pushed him back with the door, and got out of the vehicle.
- Q. Did you hit him?
- A. No.
- Q. What occured then?
- A. I asked him who do you think you are. A stated that the man said something like you are going to get a ticket, turned and walked back to his vehicle, then entered his vehicle.
- Q. What did you do then?
- A. I got back in my vehicle, then drove off, north on Main St.
- Q. Where did the man in the other vehicle go?
- A. He went straight across the intersection.
- Q. Was there anyone else in your vehicle, or the other vehicle?
- A. None in my vehicle, and I did not see anyone else in the other vehicle.
- Q. Do you know of any witnesses to the incident?
- There were many vehicles backed up behind our vehicles during the Α. incident.
- Q. Explain how the man hit you.
- He was standing at the open window to my car, then reached in, and slapped me in the forehead with the back of his hand.
- Q. Did you receive any injury due to being hit?
- A. No, it was not that hard, but did knock my hat off.
- Q. Did you report the incident to anyone?
- looked at his father for confirmation. After his father approved by nodding, stated that he had mentioned the incident to Rosemary at Aldie Counciling Center.
- Q. What did you say to Rosemary?
- A. was reluctant to say what he had told Rosemary, only that he had mentioned the incident to her.

I went to the Gulf Station at the corner of N. Main St. and Lacey Ave. The service attendants that were working on 06-29-05 at 0900 hours stated that they observed no altercation.

I went to Doylestown Floor Covering at the corner of N. Main St. and Lacey Ave. Aaron Smith, who is an employee, advised me that he was working on 06-29-05 and did remember hearing something unusual during that time. I asked him to explain. He said that he was working and heard more than one individual yelling at each other, and believed it was at the intersection.

I did telephone and request that he contact the Aldie Counciling Center and give permission for them to be interviewed in regards to my investigation.

did advise me that he would sign a written release form on 07-01-05, giving Aldie permission to speak with me.

On 06-30-2005, at approximately 1735 hrs., Dave Heckler arrived at the Police Station for his appointment to be interviewed. He was invited into the station and escorted back to the office of Police Chief, James Donnelly, to be interviewed about this incident. Present for the interview was Chief James Donnelly and myself.

Dave Heckler was told that we had received a complaint from the young man that he had asked to have a citation issued to by Ptm. Hilton. He was told that this young man was alleging that Heckler had confronted and had physical contact with him. Heckler told us that he would be happy to cooperate and give his side of this incident.

Heckler told us that he was heading out of town on Court Street. He observed a red Blazer come to the stop sign on N. Church Street at E. Court Street. The young man operating the vehicle slowed, but drove right through the stop sign. Heckler told me that he was already at the stop sign. Heckler told me that he sees this with a great deal of frequency, at least once a week in Doylestown. It made him upset that this young man did this. In his own words, Heckler told us that he acted in a pompous and overbearing way by immediately turning left onto Church and following the vehicle. Heckler admitted that he was blowing his horn at the vehicle. He told us that he was doing this in an attempt to get the vehicle to pull over. His reason for doing this was to try and identify the young man so

that he could testify as to his identity in court, if necessary. The young man in the Blazer slowed at Mechanic Street, but continued down the hill. At the bottom of the hill at Lacey Ave the Blazer stopped for the light. Heckler told us that he pulled up along side the vehicle in an attempt to draw attention to the situation by a possible passing police patrol vehicle. He approached the driver of the Blazer. He stated that he asked for the driver's name to further identify him. The young man was wearing a baseball hat pulled down low over his face. There were several exchanges between the two of them. The young man was surly and obnoxious in a typical teenage way. He told Heckler to get out of his face. The exchange continued, with Heckler repeating that he wanted the young man's identity to give to the police. The traffic light changed, and the young man started to leave. Heckler told us he reached in and pushed the brim of the baseball hat up to get a good look at the driver. Heckler told us that, at no time, did he strike this young man. Heckler said that this was probably crossing the line in the mind of the young man, as he hurriedly exited his vehicle by opening the driver's door. Heckler told us that his first reaction was to hold the car door closed, but the young man was able to exit the car. The young man then told Heckler something about being an old man and he was going to have a heart attack. He then pushed Heckler in the shoulders with both hands. At this point, Heckler told us that he realized that this could get out of control. Heckler kept both his hands at his side. He did not want to have a physical confrontation. They yelled back and forth at each other. He told me that he did not think that either one of them really wanted it to go any further, so they mutually got back into each others own car and left the area. Heckler told the young man that he was going to see that he paid for violating the motor vehicle code. The young man's parting comment was something to the point of "Yeah and you never committed a violation of the motor vehicle code".

Heckler reiterated that he never threatened the young man. He never touched the young man except to push his hat back, and the only person who was physically touched was Heckler when he was pushed in the chest.

Heckler offered up the names of two possible witnesses. They were behind him in the line of cars. One was ex-ADA Ellis Kline, who has his private practice in Bensalem, and the Law Clerk (Joel) who clerks for Judge Scott.

Heckler was asked to give a written statement of the facts of this incident. He complied with a statement that closely followed his verbal statement.

Heckler was advised that we had to interview Kline, the Law Clerk, and one other witness prior to concluding this investigation. He said he understood and would wait to hear from us.

07-01-05. David Heckler provided the names of two potential witnesses to the incident. Their names were Joel Steinman and Ellis Klein. I contacted Joel Steinman and requested that he come to the station for an interview.

At approximately 0920 hours, Steinman arrived and provided me with a written statement. The following information is based on that interview. I was coming to work at approximately 0845 hours, and came to the intersection of Main and Union. I was the first vehicle at the traffic light. Across the intersection at the traffic light were two vehicles. The first vehicle was a possibly blue in color pick-up truck. To the rear of the truck was a small white Toyota sports car. The driver of the white car got out of his vehicle and approached the driver's side of the truck. I recognized that person as Judge David Heckler.

The two drivers appeared to exchange words. I could not hear what they said, because my windows were rolled up. The driver of the truck got out of his vehicle. Then in what appeared to be an animated nose to nose discussion took place. Thinking that he may have to intervene, Steinman started to pull to the side of the road. Before I could get out of my vehicle, they separated, and got back in their respective vehicles. Steinman then drove to work. He said no punches were thrown, only some minor pushing and shoving.

Rosemary Kelly, nurse at the Aldie Counciling Center, was given written permission from to speak with me. The following information is based on my interview with Kelly.

On 06-29-05, at approximately 0915 hours, the came in for his medication. While speaking with Kelly, the stated that she would never believe what happened to him on the way in. Kelly asked him what had happened. Said that he must have rolled a stop sign, and a guy started to follow him. He stopped his vehicle, and the old man walked up to his vehicle and started to yell at him. At one point, the man flipped up his (figure 's) hat. Told Kelly that they got in to an argument, then the guy left.

I asked Kelly the following questions.

- Q. How do you know David Heckler?
- A. Through prior contact at the Courthouse.
- Q. How did appear when he was describing the incident?
- A. He appeared to be annoyed.
- Q. Did say that he was struck by the man?
- A. No, only that his hat was flipped up.

No further questions were asked of Kelly.

The following information is based on my telephone interview with Ellis B. Klein.

I was stopped in a line of traffic on Church St., directly to the rear of a white vehicle. I observed Judge David Heckler get out of the white vehicle and approach the other vehicle. I thought that they have know each other. I observed them talking, and thought that they may be arguing. I did not hear what was said because my windows were rolled up. I observed the other man get out of his vehicle. They appeared as if they were arguing, and then the man shoved Heckler back with both hands. They appeared to argue briefly, then they both entered their vehicles, and drove off.

I asked Klein the following questions.

- Q. How do you know David Heckler?
- A. Through prior contact at court.
- Q. Did you see either subject strike the other?
- A. No, only the other man shove the judge.
- Q. Did you think the man that shoved the judge did it aggressively, or to remove him from his body space?
- A. I thought it was only meant to push him away. It was not very hard, because the judge barely moved when he was shoved.
- Q. At any time did you observe Heckler reach in to the vehicle of the other man?
- A. No.

Judge Heckler does not seek prosecution of for shoving him.

At the conclusion of my investigation, it is my opinion that the evidence does not rise to the level of prosecution, and will be referred to the Bucks County District Attorney's Office for review.
